damages or payments due or payable as of the Effective Date or thereafter including, without limitation, all claims for damages by reason of past, present and future infringement or other unauthorized use of the Marks, with the right to sue for damages and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to register trademarks, to record Assignee as the assignee and owner of the Marks or any Mark under such official's jurisdiction.

Assignor hereby represents and warrants that the Marks are free and clear of any liens and encumbrances and that the Assignor has not executed and will not execute any agreement or other instrument in conflict herewith.

Assignor hereby covenants and agrees that it shall cease and refrain from all use of the Marks in all countries of the World as of the Effective Date.
