RELEASE OF TRADEMARK SECURITY INTERESTS dated as of August 18, 2015 (this "Release"), by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as administrative agent (the "Administrative Agent"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of December 5, 2011 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Jaguar Holding Company I ("Holdings"), Jaguar Holding Company II (the "Parent Borrower"), Pharmaceutical Product Development, LLC (the "Subsidiary Borrower"), the lenders party thereto and the Administrative Agent, (ii) the Security Agreement dated as of December 5, 2011 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Grantors listed therein and the Administrative Agent, (iii) the Intellectual Property Security Agreement dated as of December 5, 2011, among the Grantors listed therein and the Administrative Agent, (iv) the Intellectual Property Security Agreement Supplement dated as of September 30, 2013, among the Grantors listed therein and the Administrative Agent and (v) the Intellectual Property Security Agreement Supplement dated as of June 11, 2015, among the Grantors listed therein and the Administrative Agent (such documents set forth in clauses (i) through (v), the "Security Documents").

B. Pursuant to the Security Documents, the Persons listed on Schedule I hereto (the "Grantors") granted to the Administrative Agent, for the benefit of the holders of the Secured Obligations, a security interest in all right, title or interest of the Grantors in, among other things, the trademarks and trademark applications of the Grantors set forth on Schedule I (collectively, the "Trademark Collateral"), which security interests were recorded with the United States Patent & Trademark Office on (i) December 6, 2011 at Reel/Frame 4673/0061 for Pharmaco Investments, Inc., (ii) October 15, 2013 at Reel/Frame 5131/0586 for Acurian, Inc., (iii) June 12, 2015 at Reel/Frame 5551/0958 for Pharmaco Investments, Inc., (iv) June 12, 2015 at Reel/Frame 5551/0971 for Clinical Research Advantage, Inc. (v) June 12, 2015 at Reel/Frame 5551/0984 for Radiant Research, Inc. and (vi) June 12, 2015 at Reel/Frame 5552/0023 for CNS Research Science, Inc.

C. Pursuant to the Payoff Letter dated as of August 18, 2015, among Holdings, the Parent Borrower, the Subsidiary Borrower and the Administrative Agent, the Administrative Agent agreed to release any and all security interests it may have in the Trademark Collateral pursuant to the Security Documents.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release, relinquish and discharge any and all security interests it has against the Trademark Collateral. The Administrative Agent authorizes the Subsidiary Borrower (or their designee) to make filings with the United States Patent and Trademark Office and

other necessary filings, in each case at the expense of the Subsidiary Borrower, to evidence the release and termination of the Administrative Agent's security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE ADMINISTRATIVE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.


