RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “**Release**”) is made as of September 22, 2015, by Z Capital Commercial Finance, L.L.C., a Delaware limited liability company, as Administrative Agent under the Security Agreement referred to below (the “**Secured Party**”) for the benefit of Accel Performance Group LLC, a Delaware limited liability company (the “**Grantor**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

W I T N E S S E T H:

WHEREAS, the Grantor and the Secured Party are parties to that certain Trademark Security Agreement dated as of December 31, 2014 (as amended, restated or otherwise modified through the date hereof, the “**Security Agreement**”), pursuant to which the Grantor granted to the Secured Party for its benefit and the benefit of certain lenders, a security interest in the Trademark Collateral, which includes (a) all of its Trademarks and all Intellectual Property Licenses, including, without limitation, those referred to on Schedule 1 hereto; (b) all renewals and extensions of the foregoing; (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and (d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office at Reel 5443 and Frame 0183 on January 6, 2015; and

WHEREAS, Grantor has requested that the Secured Party release, and the Secured Party is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. The Secured Party does hereby terminate the Security Agreement and terminate, release, discharge and reassigns to the Grantor the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement to the Trademark Collateral, together with the goodwill of the business symbolized thereby, and any right, title or interest of the Secured Party in such Trademark Collateral, if any, shall hereby terminate, cease and become void.

2. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of California.
