2. Assignor further agrees to execute all extension, reissue, and other patent applications in this or any foreign country relating to the Patents and to sign all other lawful papers and to perform all other lawful acts without further consideration, but without expense to Assignor, which Assignee may deem necessary or desirable to make this Assignment fully effective, including, by way of example but not of limitation, the following acts:

- a. prompt execution of all lawful oaths, affidavits, and/or supplemental oaths required or deemed advisable by Assignee; and
- b. co-operation to the best of Assignor's ability in the execution of all lawful documents, the production of evidence, and the giving of testimony in interference, opposition, derivation, review, nullification, examination, re-examination, infringement, or other proceedings involving the Patents.

B. ASSIGNMENT OF TRADEMARKS

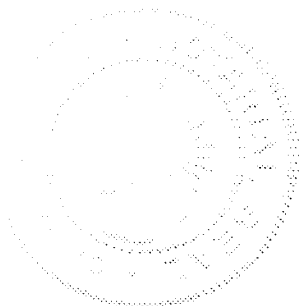
