RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of September 18, 2015 (“Effective Date”) in favor of NIMAN RANCH, INC. (“Grantor”) by ING CAPITAL LLC (the “Agent”).

WHEREAS, Niman Ranch, Inc., (“Niman Ranch”) and Agent entered into that certain Loan and Security Agreement by and between Niman Ranch, Agent, Sioux-Preme Packing Co., and the other parties thereto dated July 22, 2014 (the “Loan and Security Agreement”);

WHEREAS, pursuant to the Loan and Security Agreement, Grantor granted to Agent a security interest in all of its right, title and interest in, to and under certain intellectual property and entered into that certain Trademark Security Agreement dated July 22, 2014 (the “Trademark Security Agreement”) for the purpose of recording such security interest with respect to the trademarks of Grantor, including those items set forth on Schedule A hereto (as such term is further defined in the Security Agreement, the “Trademarks”) with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 23, 2014, at Reel 5327, Frame 0829; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademarks, including all goodwill thereto, and (iii) re-assigns to Grantor any right, title and interest it may have in, to or under the Trademarks, including, without limitation, any goodwill associated therewith, to Grantor.

Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor, at Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York and applicable federal law.
