**FIRST:** The name of the limited liability company (hereinafter called the "Limited Liability Company") is New Hurrycane LLC.

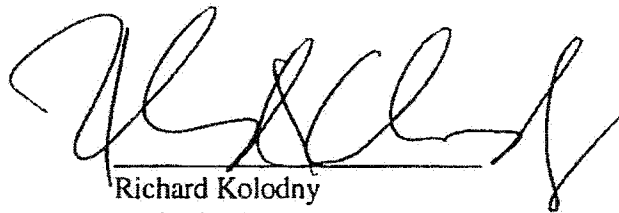
**SECOND:** The Certificate of Formation of the Limited Liability Company was filed in the Office of the Secretary of State of the State of Delaware on August 18, 2015.
