TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is made between Douglas Lambert and Jenny Lambert, individuals and U.S. citizens having a mailing address of 1924 Bayhill Dr., Las Vegas, Nevada 89117 ("Assignors") and Millionaire Properties Ltd., a Nevada Corporation,  L.L.C. having offices in Las Vegas, NV ("Assignee").

WHEREAS Assignors are the owner of the marks WINE & DINE, BILLIONAIRE and MILLIONAIRE ("Marks"), the mark WINE & DINE being the subject of U.S. Trademark Registration No. 1,878,613 registered February 14, 1995, the mark BILLIONAIRE being the subject U.S. Trademark Registration No. 1,559,779 registered October 10, 1989 and the mark MILLIONAIRE being the subject of U.S. Trademark Registration No. 1,570,858 registered December 12, 1989.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:


1. Assignors do hereby sell, transfer, assign and otherwise convey to the Assignee, its successors and assigns all Assignors' right, title and interest throughout the world, in the following:
 - (i) the Marks and any renewals thereof;
 - (ii) U.S. Trademark Registration Nos. 1,878,613 (WINE & DINE), 1,559,779 (BILLIONAIRE) and 1,570,858 (MILLIONAIRE);
 - (iii) the goodwill of that portion of Assignors' business connected with, pertaining to, and symbolized by the Marks including goodwill arising from use of the Marks by Assignors' predecessors in interest; and
 - (iv) the ownership of all causes of action for, and claims for damages by reason of infringement of the Marks, or any of them, which actions arose prior to the date of execution hereof.
2. This Trademark Assignment shall inure to the benefit of, and shall be binding upon, the successors and assigns of the parties.

3. Assignors hereby agree that the Assignee shall have the right to record this instrument of Assignment in the United States Patent and Trademark Office so as to establish the Assignee as owner of record of the Marks in the United States.




