INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT

THIS INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT (this “**IP Assignment**”), effective as of August 28, 2015, is entered into by and between Arysta LifeScience North America, LLC, a California limited liability company (the “**Assignor**”), and Valent U.S.A. WHEREAS, Assignor wishes to assign, and Assignee wishes to accept, all right, title and interest to the Aloft Product Line Intellectual Property Rights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, sells, transfers and conveys to Assignee, and Assignee’s successors, assigns and legal representatives, the entire, full and exclusive right, title, and interest in and to the Aloft Product Line Intellectual Property Rights, including the Trademarks, together with the good will of the business symbolized by the Trademarks, and the right, but not the obligation, to assert the Trademarks, and to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto by reason of any past, present and future acts of infringement that have occurred or may occur.
