**RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARK**

September 25, 2015

WHEREAS, Northern Tool & Equipment Company, Inc., a Minnesota corporation ("Grantor"), pursuant to that certain Confirmatory Grant of Security Interest in United States Trademarks effective as of April 10, 2015 ("Trademark Security Agreement"), granted to Wells Fargo Bank, National Association, for itself and for the Secured Parties ("Grantee"), a security interest in and to all of Grantor's right, title and interest in and to certain Trademark Collateral (as defined in the Trademark Agreement), including without limitation the trademark listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the "Mark");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates and releases, without representation or warranty, all of Grantee's right, title and interest in and to the Mark. No Trademark Collateral other than the Mark is released from the Trademark Security Agreement, which otherwise remains in full force and effect in accordance with its original terms in all respects.


