TRADEMARK RELEASE OF SECURITY INTEREST

This TRADEMARK RELEASE OF SECURITY INTEREST (this "Release") is made and effective as of September 23, 2015, and granted by Roynat Business Capital Inc., a Delaware corporation ("Secured Party"), in favor of Unishippers Global Logistics, LLC, a Delaware limited liability company ("Grantor").

1. Secured Party hereby releases its security interest in all of Grantor's right title and interest in, to and under the Specified Trademark Collateral.

2. To the extent, if any, that following the release as set forth in Section 1 above, Secured Party retains or would retain any right, title or interest in, to or under the Specified Trademark Collateral or any goodwill of any business conducted in connection therewith, Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Secured Party, all of Secured Party's right, title and interest in, to and under the Specified Trademark Collateral and the goodwill of Grantor's business connected with the use of and symbolized by the Specified Trademark Collateral.


