ASSIGNMENT

Assignor further assigns to Assignee all right to sue for and receive all damages accruing from past infringements of the Mark assigned. Assignor represents and warrants that it is the sole owner of the Mark and has the authority to assign the Mark to assignee.

This Assignment shall be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.
