TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of September 28, 2015 (the "Effective Date") by and between **Nordic Cold Storage Holdings, LLC**, a Delaware limited liability company ("Assignor") and **Nordic Cold Storage Holdings II, LLC**, a Delaware limited liability company ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Mark, together with (a) all of the goodwill associated with the mark and the business to which it relates, (b) any renewals and extensions of the Mark, (c) all common law rights with respect to the Mark, (d) all other corresponding rights that are or may be secured under the laws of the United States or any other jurisdiction (including the right to file for any mark based on the Mark in any jurisdiction outside of the United States), now or hereafter in effect, and (e) all income, royalties or payments due or payable as of or after the Effective Date, including, without limitation, all claims for damages by reason of past, present or future infringement, dilution, violation, or other unauthorized use of the Mark or any of the foregoing, with the right to sue for, and collect the same, in each case for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby requests the Commissioner for Trademarks of the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Mark.
