## TRADEMARK ASSIGNMENT

Assignee acknowledges that the assignment of the Marks herein is made on an "As Is" basis, and Assignor makes no representation or warranty regarding the Marks, except as may be expressly set forth in an Asset Purchase Agreement executed between the parties as of the Effective Date. From and after the Effective Date, Assignee shall be solely responsible for any use or registration of the Mark.
3. Assignor further agrees, without further consideration, to cause to be performed such other lawful acts and to be executed such confirmatory assignments and other legal documents as Assignee, or its counsel, may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of each of the rights hereby conveyed.
