RELEASE OF SECURITY INTEREST IN TRADEMARK

This RELEASE OF SECURITY INTEREST IN TRADEMARK is made as of September 30, 2015, by Marquette Capital Fund I, LP, a Delaware limited partnership, with a place of business at 60 South Sixth Street, Suite 3510, Minneapolis, MN 55402, for itself and as agent for Argosy Investment Partners III, L.P. and First Mezzanine Investors, LLC (f/k/a First Capital Partners, LLC) (in such capacity, the "Collateral Agent"), regarding Wisconsin Film & Bag, Inc., a Wisconsin corporation with a place of business located at 3100 East Richmond Street, Shawano, Wisconsin 54166 (the "Debtor"), and with reference to the following facts:

WHEREAS, the Debtor, certain affiliates of the Debtor and the Collateral Agent have previously entered into a Trademark Security Agreement dated as of October 3, 2007, as amended to date, (collectively, the "Security Agreement"), for the purpose of securing certain obligations of the Debtor to certain lenders and the Collateral Agent (recorded at the U.S. Patent and Trademark Office at Reel/Frame: 4421/0769 on November 27, 2010); and

WHEREAS, the Collateral Agent desires to release any security interest it might have in the personal property of the Debtor that was granted to the Collateral Agent pursuant to the Security Agreement;

NOW, THEREFORE, for valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Collateral Agent releases any and all security interests held by it in and to any and all of the trademarks, service marks, applications therefor and associated goodwill therein, owned by the Debtor, including without limitation those trademarks listed on Exhibit A attached hereto, and in and to all proceeds and benefits thereof.


