NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of September 30, 2015, is made by MIDCAP FUNDING X TRUST, a Delaware statutory trust and successor by assignment from MidCap Financial Trust, in its capacity as Agent for the Lenders party to the Credit Agreement (defined below) (together with its successors and assigns, "Grantee"), and is as follows:

WHEREAS, ISI BRANDS INC., a Michigan corporation ("Grantor"), and Grantee are parties to that certain Trademark Security Agreement dated as of January 22, 2015 which was recorded with the United States Patent and Trademark Office on January 27, 2015 in its records at Reel 5447 Frame 0150 (the "Agreement"), capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted and assigned to Grantee a security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including the following (the following collectively referred to herein as the "Released Trademark Collateral"): (a) all of Debtor's right, title and interest in and to the existing Trademark listed on Schedule I of this Agreement (the "Released Trademark") together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, the Released Trademark; and (b) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of the Released Trademark, or (ii) injury to the goodwill associated with any Released Trademark; and

WHEREAS, Grantee desires to release its rights and security interests in the Released Trademark Collateral only.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee hereby releases and terminates its security interest and other rights in, to and under the Released Trademark Collateral. Except as expressly partially released hereby, the Agreement remains in full force and effect.


