RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST ("Release") is made and effective as of September 30, 2015.

WHEREAS, by that certain Senior Subordinated Intellectual Property Security Agreement dated as of February 28, 2014 (the "IP Security Agreement"), originally recorded with the Patent Assignment Recordation Branch of the United States Patent and Trademark Office ("USPTO") on April 10, 2014 at Reel/Frame 032643/0196 and recorded with the Trademark Assignment Recordation Branch of the USPTO on April 10, 2014 at Reel/Frame 5257/0596, VANNER, INC., a Delaware corporation, VANNER PARTNERS HOLDING, LLC, an Ohio limited liability company, VANNER HOLDINGS, INC., an Ohio corporation, and VHI HOLDINGS, INC., an Ohio corporation (collectively, the Pledgor) granted to THE HUNTINGTON CAPITAL INVESTMENT COMPANY II, an Ohio corporation with an address of 41 South High Street, Columbus, Ohio 43215 ("Releasor"), a second priority security interest in the Collateral (as defined in the IP Security Agreement), including all of Pledgor's existing and future right, title and interest in, to and under certain intellectual property including the patents/patent applications, trademark applications/registrations, common law trademarks, domain names and copyrights identified in Schedule 1 (collectively, the "Intellectual Property");

WHEREAS, Releasor wishes to provide a document suitable for recording with the Patent and Trademark Assignment Recordation Branch of the USPTO for purposes of recording the release, relinquishment and discharge of its security interest in the Intellectual Property;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Releasor does hereby terminate, release and discharge any and all security interests that it has in the Collateral, including the Intellectual Property, pursuant to the IP Security Agreement, and further releases any and all other rights it may have under the IP Security Agreement and reassigns to the Pledgor any and all right, title and interest that it may have, in, to and under the Collateral, including the Intellectual Property, pursuant to the IP Security Agreement.

Releasor agrees to take all further actions, and provide to the Pledgor and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Pledgor and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this release.
