NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of September 30, 2015, is made by PENTA MEZZANINE SBIC FUND I, LP, a Delaware limited partnership (together with its successors and assigns, "Grantee"), and is as follows:

WHEREAS, ISI BRANDS INC., a Michigan corporation ("Grantor"), and Grantee are parties to that certain Trademark Security Agreement dated as of January 22, 2015 which was recorded with the United States Patent and Trademark Office on January 22, 2015 in its records at Reel 5445 Frame 0473 (the "Agreement"), capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted and assigned to Grantee a security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including the following (the following collectively referred to herein as the "Released Trademark Collateral"): (a) all of Debtor's right, title and interest in and to the existing Trademark listed on Schedule I of this Agreement (the "Released Trademark") together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, the Released Trademark; and (b) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of the Released Trademark, or (ii) injury to the goodwill associated with any Released Trademark; and

WHEREAS, Grantee desires to release its rights and security interests in the Released Trademark Collateral only.


