The Converted Entity will remain liable for payment of all fees and taxes required by Texas law to be paid by the Converting Entity.

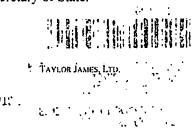

If the TBOC or other applicable law is amended to authorize action further eliminating or limiting the liability of a manager, then the liability of a manager shall be eliminated or limited to the fullest extent permitted by the TBOC or other applicable law, as so amended. Any repeal or modification of this paragraph shall not adversely affect the right or protection of a manager existing at the time of such repeal or modification.

This limited liability company is being formed pursuant to a Plan of Conversion. Prior to conversion, the limited liability company was a Texas limited partnership by the name of Taylor James, Ltd., which was formed on February 4, 2004, and had a principal business address of 314 E.
