WHEREAS, the security interest was recorded at the United States Patent and Trademark Office on November 18, 2013 at 5155, Frame 0752; and


WHEREAS, the Agent has agreed to terminate and release its security interest in the Trademarks as herein provided.

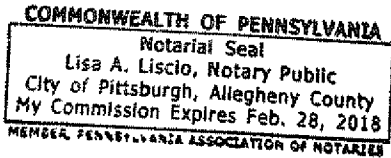
