**ARTICLES OF INCORPORATION
of
ELEVATIONS CREDIT UNION**

We, the undersigned residents of the State of Colorado, do hereby execute and adopt the following Articles of Incorporation of Elevations Credit Union as follows:

ARTICLE I

Name and Address

1. The name of said Credit Union shall be Elevations Credit Union.
2. The Credit Union shall maintain its principal place of doing business at 2300 55th St., Boulder, Colorado.

ARTICLE II

Purpose and Powers

1. The purposes for which this Credit Union shall be organized and incorporated are to promote thrift among its members and create a source of credit for them at fair and reasonable rates of interest.
2. The powers of the Credit Union shall consist of those powers conferred upon it by the appropriate provisions of Article 30 of Title 11, Colorado Revised Statutes.

ARTICLE III

Term of Existence

1. The term of existence of the Credit Union shall be perpetual.

ARTICLE IV

Membership

1. Membership in the Credit Union shall be limited to those specified in the Elevations Credit Union Bylaws.

ARTICLE V

Capital

1. The capital of the Credit Union shall be unlimited in amount and shall consist of shares having a par value as determined by the bylaws.

ARTICLE VI

**ARTICLES OF INCORPORATION FOR A NONPROFIT CORPORATION
ATTACHMENT**

Distribution of Assets Upon Dissolution
Colorado Statute 11-30-120 (3)

Under any procedure to dissolve and liquidate a Credit Union (Elevations Credit Union) pursuant to subsection (1) or (2) of section 11-30-120 of the Colorado Credit Union Statutes, the credit union shall continue in existence for the purpose of discharging its debts, collecting and distributing its assets, and doing all acts required in order to wind up its business and it may sue and be sued for the enforcement of its debts and operations until its affairs are fully adjusted in liquidation. The assets of the credit union shall be used to pay: First, the expenses incidental to liquidation, second, liabilities due nonmembers; and third, deposits and savings club accounts. Any remaining assets shall be distributed to the members proportionately to the shares held by each member as of the date of dissolution.

CERTIFICATE OF APPROVAL

WHEREAS, on October 31, 2006, the State Commissioner of Financial Services (“Commissioner”) received an application for approval to incorporate a state-chartered credit union, to be know as Elevations Credit Union (“Credit Union”), located in Boulder, Colorado; and

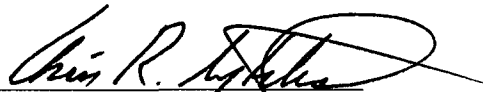
WHEREAS, the Commissioner also received executed articles of incorporation and bylaws for said Credit Union at a later date; and

WHEREAS, upon investigation of the application and other documents, the Commissioner has determined the following:

1. The application, articles of incorporation and bylaws conform to Article 30 of Title 11, C.R.S.
2. The Credit Union would benefit the members and proposed members thereof, consistent with the purposes of Article 30 of Title 11, C.R.S.
3. The incorporators appear to possess the general character, fitness and qualifications to operate the Credit Union in a sound and lawful manner.
4. The establishment of the proposed Credit Union appears to be economically advisable.

NOW THEREFORE, IT IS HEREBY ORDERED that, pursuant to C.R.S. 11-30-101 (4), the incorporation of Elevations Credit Union is approved. Further, this constitutes the Commissioner’s approval of the filing of the Credit Union’s articles of incorporation (attached hereto) with the Colorado Secretary of State.
