## GRANT OF SECURITY INTEREST

This GRANT OF SECURITY INTEREST, dated as of September 30, 2015, is executed by SUNSTREAM CORPORATION, a Washington corporation (the “**Grantor**”), in favor of SIENA LENDING GROUP LLC (“**Lender**”).

A. Pursuant to a Loan and Security Agreement dated as of the date hereof (as amended, restated, or otherwise modified from time to time, the “**Loan Agreement**”), by and between Grantor and Lender, Lender has agreed to extend certain credit facilities to Grantor upon the terms and subject to the conditions set forth therein.

B. Grantor owns the trademarks, copyrights, applications for trademarks, and/or applications for copyrights, of the United States, more particularly described on Schedules 1-A and 1-B annexed hereto as part hereof (collectively, the “**Intellectual Property**”);

C. Grantor has entered into an Intellectual Property Security Agreement dated the date hereof (the “**Security Agreement**”) in favor of Lender; and

D. Pursuant to the Security Agreement, Grantor has granted to Lender a security interest in all right, title, and interest of Grantor in and to the Intellectual Property, together with any reissue, continuation, continuation-in-part, or extension thereof, and all proceeds thereof, including any and all causes of action that may exist by reason of infringement thereof for the full term of the Intellectual Property (collectively, the “**Collateral**”), to secure the prompt payment, performance, and observance of the Obligations, as defined in the Security Agreement;

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby further grant to Lender a security interest in the Collateral to secure the prompt payment, performance, and observance of the Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Lender with respect to the security interest in the Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.



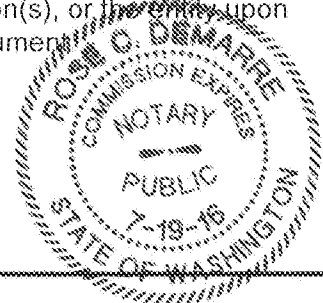
