## TRADEMARK PURCHASE AGREEMENT

WHEREAS, Purchaser wishes to purchase from Seller and Seller wishes to sell and assign to Buyer the Marks on the terms and conditions hereinafter provided.

- (a) "Acquired Assets" shall mean the Intellectual Property Rights and the Marks.
- (b) "Intellectual Property Rights" shall mean any Trademarks, right of Trademarks registration or re-registration, common law Trademarks right and goodwill associated with the Marks.

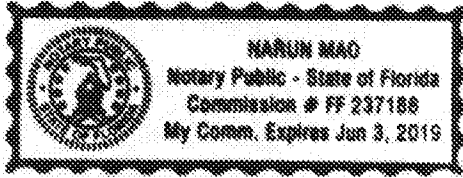
