A *nunc pro tunc* assignment of U.S. Application No. 78/797,706, executed 25 April 2013, with an effective date of 19 June 2012, from The Sanctuary at Covent Garden Limited to PZ Cussons Beauty LLP, a limited liability partnership of England and Wales, was recorded on 2 May 2013. In fact, the assignee PZ Cussons Beauty LLP was

and is a limited liability partnership of the United Kingdom. This mistake in the manner in which the assignee was identified in the assignment was made in good faith and with no intent to deceive.

4. It is clear to me that the PZ Cussons Beauty LLP identified by the two assignments and PZ Cussons Beauty LLP, a limited liability partnership of the United Kingdom, are the same entities.

5. The mistakes in the manner in which the country of organization of PZ Cussons Beauty LLP were identified in the *nunc pro tunc* assignment with an effective date of 2 June 2011 and the *nunc pro tunc* assignment with an effective date of 19 June 2012 of U.S. Application No. 78/797,706 were made in good faith with no intent to deceive.
