Under Section 242 of the Delaware Corporation Law

Pursuant to Sections 242 of the General Corporation Law of the State of Delaware, the undersigned, being the Chief Financial Officer and Secretary of Lodis Accessories, Inc., a Delaware corporation (the "Corporation") does hereby certify the following:

FIRST: The name of the Corporation is Lodis Accessories, Inc.

SECOND: The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on January 12, 2006.

THIRD: The Certificate of Incorporation of the Corporation is hereby amended to effect a change in ARTICLE ONE thereof, relating to the name of the Corporation. Accordingly, ARTICLE ONE of the Certificate of Incorporation shall be amended to read in its entirety as follows:
