BACKGROUND:

- (A) The Assignor is the proprietor of the trade marks listed in the Schedule to this document ("the Trade Marks").
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out below.

AGREED TERMS

1. Assignment

In consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor acknowledges) the Assignor assigns to the Assignee:

- (a) all its right, title and interest in the Trade Marks; and
- (b) all rights of action, powers and benefits arising from ownership of the Trade Marks, including the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising prior to, on or after the date of this Assignment.

2. Further assurance

- (a) The Assignor authorises the representatives of the Assignee, at the cost of the Assignee, to record the Assignee as proprietor of the Trade Marks.
- (b) The Assignor wishes to transfer and assign to the Assignee all of the Assignor's right, title and interest in and to the Trade Marks and the goodwill associated therewith.

3. Governing law

This Assignment shall be governed by and construed in accordance with the laws of England and Wales.
