TERMINATION OF SECURITY INTEREST IN  
TRADEMARKS AND RE-ASSIGNMENT OF INTERESTS

WITNESSETH:

WHEREAS, EASY GARDENER PRODUCTS, INC. 

NOW, THEREFORE, for valuable consideration, Agent hereby agrees as follows:

Agent hereby releases and terminates its security interest and lien in the registered trademarks and trademark applications identified on Schedule A to this Instrument (and in the goodwill associated therewith), (the "Released Marks") and Agent re-assigns to the Grantor all its right, title and interest (if any) in and to the Released Marks. Such termination and re-assignment shall apply as well to the trademarks that have been registered pursuant to such trademark applications. The U.S. Patent and Trademark Office is hereby authorized and requested to discharge the Security Agreements of record as to each of the Released Marks.
