ASSIGNMENT OF TRADEMARK

This Assignment of Trademark is made pursuant to the terms of the Settlement Agreement dated June 1, 2015, by and between Trek Bicycle Corporation, a Wisconsin corporation having its principal place of business at 801 West Madison, Waterloo, Wisconsin 53594 ("Trek") and Convaid, a California corporation with a principal place of business at 2830 California St., Torrance, California 90503-3908 ("Convaid").

WHEREAS, Trek ("Assignee") is desirous of using the TREKKER mark and acquiring the entire right, title and interest thereto, and the goodwill of the business symbolized thereby for the United States and the rest of the world.

NOW THEREFORE, in consideration of the mutual covenants of the parties, Trek and Convaid agree as follows on a worldwide basis.



Assignor hereby sells, assigns, conveys and transfers unto Assignee for the United States and the rest of the world all right, title and interest in, to and under the TREKKER mark together with (1) all associated common law and statutory rights, (b) the goodwill of the business symbolized thereby, and (c) all rights and privileges granted and secured thereby, including without limitation, the right to sue and recover for any past or continuing infringement of the TREKKER mark, as well as the right to seek any and all remedies available at law or in equity.

2. All said right, title and interest shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment of Trademark had not been made.

3. Assignor agrees to sign any additional documents needed in order to record this assignment for the United States.
