RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party, without representation, warranty or recourse, hereby terminates and releases its security interest in the Trademarks and Trademark Licenses, including, without limitation, the trademarks identified on Schedule A attached hereto, effective as of the date set forth above.

The Secured Party acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.

This Release of Security Interest in Trademarks shall be governed by, and construed in accordance with, the laws of the State of Florida, without giving effect to any conflict of law principles thereof.
