**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is given as of October 9, 2015 to AMERICAN FAST FREIGHT, INC., a Washington corporation (the "Grantor"), by PNC BANK, NATIONAL ASSOCIATION, in its capacity as collateral agent (in such capacity, the "Collateral Agent"), with respect to the Grantor's trademarks, including those identified on Exhibit A to this Release (the "Released Trademarks").

WHEREAS, the Grantor and Collateral Agent entered into that Trademark Security Agreement, dated as of March 15, 2013 (the "Trademark Security Agreement"), and recorded in the United States Patent and Trademark Office on March 15, 2013 at Reel/Frame No. 004983/0893; and

WHEREAS, Collateral Agent desires to release its security interest in and liens upon the Released Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby states as follows:

1. Release. For good and valuable consideration previously tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of itself and in its capacity as Collateral Agent, hereby (i) terminates the Trademark Security Agreement, (ii) releases and discharges its lien on and security interest in the Released Trademarks and any and all right, title and interest of any nature whatsoever which it may hold in or to the Released Trademarks, (iii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Released Trademarks, (iv) reassigns any and all right, title and interest of any nature whatsoever which it may have in or to the Released Trademarks to the Grantor and (v) agrees that it shall execute all other documents and do all other acts requested in writing by the Grantor and reasonably necessary to relinquish, confirm, effectuate or record this Release and the Grantor's right, title and interest in and to the Release Trademarks.


2. Recordation of Trademark Release. This Release has been executed and delivered by Collateral Agent for the purpose of recording with the United States Patent and Trademark Office.

3. Governing Law. This Release shall be construed in accordance with the laws of the State of New York without giving effect to any conflict of law principles (but giving effect to laws relating to national banks).
