IN INTELLECTUAL PROPERTY**


WHEREAS, AMERICAN IN-HOME CARE, LLC, a Delaware limited liability company (the “Pledgor”) is the owner of the trademark applications and registrations listed on Schedule A attached hereto (all such trademarks, registrations and applications, collectively, the “Intellectual Property”); and

WHEREAS, the Pledgor has entered into a Pledge and Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), dated as of October 8, 2015, in which the Pledgor has agreed with Kian Mezzanine Partners I, L.P., as Collateral Agent (the “Collateral Agent”), with offices at 4720 Piedmont Row Drive, One Piedmont Center, Suite 421, Charlotte, NC 28210, to execute this Grant;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Secured Obligations (as defined in the Security Agreement), the Pledgor does hereby grant to the Collateral Agent a security interest in all of its right, title and interest in and to the Intellectual Property, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Intellectual Property. Notwithstanding the foregoing, the Intellectual Property shall not include any Excluded Property (as defined in the Security Agreement). This Grant has been given in conjunction with the security interest granted to the Collateral Agent under the Security Agreement, and the provisions of this Grant are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.
