RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby agrees as follows:

1. Assignor hereby releases, relinquishes and discharges in its entirety any and all collateral pledges, grants, assignments, liens and security interests it has on or in the Intellectual Property Collateral. All rights of Assignor arising under the Security Agreement in and to the Intellectual Property Collateral hereby revert to Assignee.
2. Assignor hereby agrees, at the sole cost and expense of Assignee, to take any reasonable actions and to execute any further documents necessary or reasonably requested by Assignee to effectuate, record or evidence the release of Assignor's security interest in the Intellectual Property Collateral.
3. Assignor authorizes and requests the relevant authority at the United States Patent and Trademark Office, the United States Copyright Office and/or the applicable foreign authorities to record this Release against the Intellectual Property Collateral, as applicable.
