TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement, effective as of September 30, 2015 (the "Effective Date"), is made by Cheminova, Inc., a corporation organized under the laws of the State of Delaware ("Assignor"), in favor of FMC Corporation, a corporation organized under the laws of the State of Delaware ("Assignee").

Background

A. Assignor owns the trademarks and trademark applications set forth on Schedule A hereto (collectively, the "Trademarks"), and all applicable goodwill associated with the Trademarks.

B. Assignor now desires to transfer to Assignee the Trademarks and all associated goodwill; Assignee desires to acquire the same.

Terms and Conditions

For good and valuable consideration, the receipt and sufficiency of which Assignor acknowledges, Assignor agrees as follows:

1. As of the Effective Date, Assignor transfers and assigns to Assignee its rights in the Trademarks, all applicable goodwill associated with the Trademarks, the portion of the business to which the Trademarks pertain, the right to file applications and receive registrations therefor, the right to exploit the Trademarks in any way desired, and the right to sue for damages and other relief for past and future infringement and/or dilution of any rights in and to the same.



Assignor will do all acts and sign all further documentation, in each case as deemed reasonably necessary or appropriate by Assignee, in order to effect or memorialize such transfer and assignment and to enable Assignee to register, enforce, or maintain the Trademarks as Assignee deems advisable, in the United States of America and throughout the world.

3. Assignor has caused this Assignment to be executed by its duly authorized officer, who certifies that he/she is duly authorized to execute this document on behalf of Assignor.
