

PARTIES

- (1) Terry de Gunzburg, of Elmfield House, 1A Neville Terrace, London, SW7 3AT, UK (the 'Assignor'); and
- (2) Mesyl Limited a company incorporated on the Isle of Man whose registered office is at Bridge House, Bridge Street, Castletown, Isle of Man, IM9 1AX (the 'Assignee').

RECITALS

- (A) The Assignor is the proprietor of the trade marks registered or the subject of applications for registration (the 'Trade Marks', which term shall include any registered trade marks resulting or arising from any such applications for registration) and the patents registered or the subject of applications for registration (the 'Patents', which term shall include any registered patents resulting or arising from any such applications for registration) in the countries listed in the attached schedule.
- (B) The Assignor has agreed to assign all its right, title and interest in and to the Trade Marks and Patents to the Assignee for the consideration mentioned below.

OPERATIVE PROVISIONS

1. In consideration of the Issue of 1000 ordinary shares of £1 each in the capital of the Assignee to the Assignor (the receipt of which is hereby acknowledged), the Assignor with full title guarantee hereby assigns to the assignee:
 - 1.1 ALL property, right, title and interest in the Trade Marks including all common-law rights attaching to them including the right to sue for past infringement and to institute proceedings for passing-off and to retain all damages obtained thereby together with the goodwill of the business in the goods and services for which the trade marks are registered TO HOLD the same unto the assignee absolutely;
 - 1.2 the Patents and the full and exclusive benefit thereof together with all re-issues and extensions of such granted Patents.
2. This Assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks and Patents (including proceedings against any third party for infringement of the Trade Marks or Patents or for passing off or for otherwise

infringing the rights of the Assignor in the Trade Marks or Patents). The Assignor agrees and undertakes to provide to the Assignee (at its request) all such assistance with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Trade Marks or Patents and the Assignee shall indemnify the Assignor in respect of all costs and expenses (including reasonable legal costs) actually incurred by it in providing the Assignee with such assistance.

3. The Assignor covenants that at the cost and request of the Assignee at any time and from time to time it will execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment or allow the recordal of this Assignment.
4. This Assignment shall be governed by and construed in accordance with the laws of the Isle of Man and the parties hereto submit to the exclusive jurisdiction of the courts of the Isle of Man.

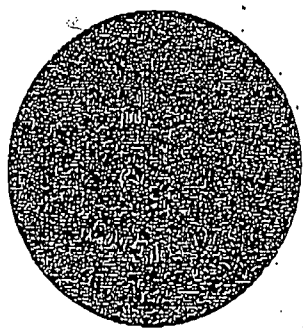

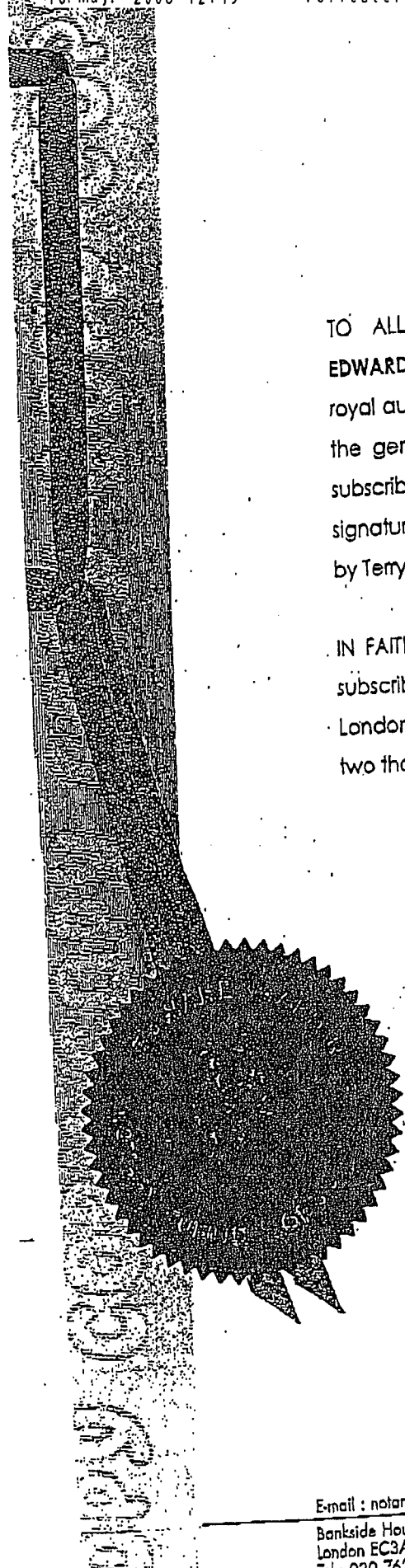
