TERMINATION AND RELEASE OF TRADEMARK ASSIGNMENT OF SECURITY

THIS TERMINATION AND RELEASE OF GRANT OF TRADEMARK ASSIGNMENT OF SECURITY (this "Termination"), is dated as of September 22, 2015, and made by **CAPITAL BUSINESS CREDIT LLC**, ("Lender") to **HAUTE HIPPIE US LICENSING LLC**, a Delaware limited liability company ("Guarantor").

WHEREAS, pursuant to a Guaranty executed by Guarantor in favor of Lender dated as of April 8, 2014 (the "Guaranty") and a Trademark Assignment of Security dated as of April 8, 2014, made by Guarantor in favor of Lender (the "Trademark Security Agreement"), a security interest was granted by the Guarantor to Lender in the Trademark Collateral (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 2, 2014, at Reel 5273 and Frame 0073; and

WHEREAS, Lender now desires to terminate and release the Trademark Security Agreement;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of certain obligations, indebtedness and liabilities secured pursuant to the Guaranty and the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Lender hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Guarantor's right, title and interest of every kind and nature, in, to and under the following:


- (a) the trademarks listed on Schedule A hereto (the "Marks");
- (b) the goodwill of the business symbolized by the the Marks; and
- (c) all registrations and applications for the Marks.

2. Release of Security Interest. Lender hereby terminates the Trademark Security Agreement and terminates, releases and discharges its security interest in the Marks and the other Trademark Collateral. Lender hereby authorizes Guarantor or its designee to file this Termination with the United States Patent and Trademark Office.
