
AND, Assignor hereby warrants and covenants that it has the full right to convey the entire interest herein assigned and that it will not execute any agreements inconsistent herewith.



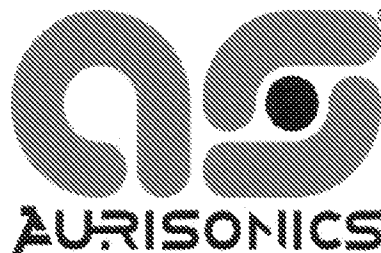
