SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This Supplement to Trademark Security Agreement (this "*Supplement*") is made as of the 8th day of October, 2015, by DOCUSIGN, INC., a Delaware corporation, and Cartavi, LLC, a Delaware limited liability (each and together, jointly and severally, the "*Grantor*"), in favor of Silicon Valley Bank, as administrative agent for certain secured parties (in such capacity, together with its successors and assigns in such capacity, the "*Administrative Agent*").

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement dated May 8, 2015 (as amended and of record from time to time hereinafter, the "*Grant*") in favor of the Administrative Agent, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Trademarks (as defined therein).

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. **Definitions.** All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. **Supplement to Schedule A.** Schedule A to the Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto.
3. **Miscellaneous:**
 - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.


