RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Jessica London, Inc., a Delaware corporation (“Grantor”) granted a continuing security interest in and lien upon certain trademarks and related rights to Wells Fargo Bank, National Association, in its capacity as administrative and collateral agent (in such capacity, “Grantee”), as set forth in the Grant of Security Interest in United States Trademarks, dated July 28, 2011, between Grantor and Grantee (the “Trademark Security Agreement”);

1. releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Grantee pursuant to the Trademark Security Agreement in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to Grantee pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.

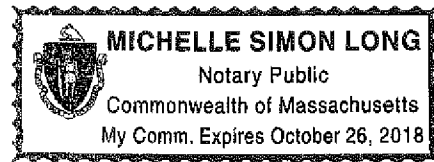
