RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of October 2, 2015, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Secured Party").

Secured Party hereby authorizes the recordation of this Release with the USPTO. Secured Party agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Secured Party's security interest in the Released Trademarks and the termination of the Trademark Filings.
