## ASSIGNMENT OF TRADEMARKS

Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title, and interest in and to said marks in the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor and can be obtained or performed without unreasonable burden on Assignor.

Assignor agrees to perform all reasonable affirmative acts that may be necessary or desirable to perfect the above-described transfer of trademarks; service marks, and trade name rights, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to said marks, at Assignee's expense.
