

HEREBY FURTHER SELLS, ASSIGNS, TRANSFERS AND SETS OVER unto the Assignee any income, royalties, damages, or payment due or payable as of the date hereof or hereafter with respect to the TPT Marks, including, without limitation, any claims for damages by reason of past, present or future infringement or other unauthorized use of the TPT Marks, with the right to sue for, and collect the same for the Assignee's own use and enjoyment, and for the use and enjoyment of its successors and assigns.

Assignee or Assignor, on request of Assignee, shall record this assignment with the Trademark Office, by electronic filing of a Recordation Form Cover Sheet along with a copy of this assignment upon the date hereof.
