RELEASE AND TERMINATION OF TRADEMARK SECURITY INTEREST

WHEREAS, LSSi Data Corp., a Delaware corporation (herein referred to as "Grantor"), owns the trademark registration listed on Schedule 1 annexed hereto and incorporated herein by reference;

WHEREAS, reference is made that certain Credit Agreement dated as of December 19, 2006 (as amended, restated, supplemented or modified from time to time, the "Credit Agreement") among Volt Delta Resources, LLC, the financial institutions from time to time party thereto and Wells Fargo Bank, National Association, as administrative agent for the Lenders ("Wells Fargo Bank"), administrative agent for such lenders; and

WHEREAS, reference is also made that certain Guarantee and Collateral Agreement dated as of December 19, 2006 (as amended, restated, supplemented or modified from time to time, (the "Collateral Agreement") among Grantor, the other grantor parties thereto and Wells Fargo Bank, as administrative agent for the secured parties thereto (in such capacity, "Grantee"); and

WHEREAS, pursuant to the terms of the Collateral Agreement, Grantor granted to Grantee for the ratable benefit of such secured parties a continuing security interest in or Lien on, among other things, the Trademark Collateral (as defined hereinafter) to secure the Secured Obligations (as defined in the Collateral Agreement);

WHEREAS, in furtherance thereof, Grantor and Grantee also entered into that certain Trademark Security Agreement, dated as of January 16, 2008 (the "Trademark Security Agreement"), in which Grantor granted to Grantee, a security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined therein) including, without limitation, the trademark registration listed on Schedule 1 thereto which was recorded in the US Trademark Office Assignment Branch on February 1, 2008 at Reel 003711, Frames 00380 to 0385; and

WHEREAS, on or about August 12, 2009, the obligations under the Collateral Agreement and the Trademark Security Agreement secured by the Trademark Collateral were repaid in full and security interests and Liens granted in connection therewith were, or were to be terminated and released; and

WHEREAS, the records of the US Patent and Trademark Office Assignment Branch do not indicate that the Trademark Security Agreement was terminated and released of record;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantee hereby absolutely and irrevocably releases and terminates its security interest and Liens granted in and to the Trademark Collateral under the Collateral Agreement and the Trademark Security Agreement including, without limitation, the Trademarks set forth on Schedule 1 hereto.
