1. Assignment of Trademark. Assignor does hereby sell, convey, transfer, assign, and deliver to the Assignee, and the Assignee hereby accepts from the Assignor, all of the worldwide right, title and interest of Assignor in, to, and under the Trademark, free and clear of all liens, together with all common law rights associated with the registration of the Trademark, and all good will associated with the Trademark and symbolized thereby, together with the right to sue and recover damages for past, present, and future infringements, unauthorized use, misappropriation, dilution, or violation by any person or entity of the Trademark and to fully and entirely stand in the place of Assignor in all matters related to the Trademark.
2. No Third Party Beneficiaries. This Trademark Assignment shall be binding upon and inure solely to the benefit of the Assignor and Assignee and each of their respective successors and assigns and nothing herein, express or implied, is intended to or shall confer upon any other person or entity, and legal or equitable right, benefit or remedy of any nature whatsoever, under or by reason of this Trademark Assignment.
3. Governing Law. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Trademark Assignment shall be governed by and construed in accordance with the laws of the State of California without giving effect to any conflict of law provision (whether of the State of California or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of California.

4. Jurisdiction. The parties hereto agree that this Trademark Assignment was entered into and executed in the State of California, County of San Diego, and irrevocably submit to the exclusive jurisdiction of any federal or state court located in the State of California over any dispute arising out of or relating to this Trademark Assignment, and each party hereby irrevocably agrees that all claims in respect to such dispute, or any suit, action, or proceeding related thereto, may be heard and determined in such courts. The parties hereto hereby waive, to the fullest extent permitted by applicable law, any objection which they may now or hereafter have to the laying of venue of any such dispute brought in such court and any defense of inconvenient forum for the maintenance of such dispute.
