## ASSIGNMENT OF TRADEMARKS

### RECITALS

- A. Assignor dissolved on February 28, 2015.
- B. After making arrangements to pay its creditors, Assignor owned the trademarks set forth in Schedule A attached to this Assignment (the "Marks").
- C. Assignee is the sole shareholder of Assignor.
- D. Assignor desires to assign all rights, title, and interests in and to the Marks ("All Rights in the Marks") to Assignee in accordance with §607.1405, Florida Statutes.


Now, therefore, in consideration of the foregoing premises, Assignor assigns, sets over and transfers to Assignee All Rights in the Marks and the goodwill associated with the Marks. The rights of Assignee at common law and to the end of the term or terms of which registration of the Marks may be granted or renewed are to be held and enjoyed by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of his personal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made; including all claims for royalties for licensing of the Marks and damages by reason of past infringements of the Marks, with the right to sue for and collect the same for his use and benefit and, for the use, benefit and on behalf of his personal representatives and assigns.

This Assignment shall be binding upon Assignor and Assignee and their successors, personal representatives and assigns. This Assignment shall be governed by, interpreted under, and construed and enforced in accordance with the laws of Florida, without regard to its conflict of laws principles. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.
