TRADEMARK ASSIGNMENT

This Trademark Assignment (“**Assignment**”) is entered into this 5th day of October, 2015 (“Effective Date”) by and between Marvin J. Adcock, Sr. (“Assignor”) and Daniel C. Adcock (“Assignee”) (Assignor and Assignee may be referred to herein, collectively as the “Parties” or each, individually, a “Party”).

RECITALS

WHEREAS, Assignor has established certain trademark and other proprietary rights in and to those certain service marks known as the DrivePros word mark (“Cited Mark I”) and the DrivePros stylized & design mark (“Cited Mark II”) (Cited Mark I and Cited Mark II may be referred to herein, collectively, as the “Marks”); and

WHEREAS, Assignor now wishes to assign any and all of his rights in and to the Marks to Assignee and Assignee wishes to accept same and assume any and all obligations, duties and liabilities with respect to same.

AGREEMENT

NOW, THEREFORE, the Parties, for good and valuable consideration the sufficiency of which is hereby acknowledged, do hereby agree to the following terms, conditions, covenants and representations.

1. **Assignment.** Assignor hereby assigns to Assignee any and all of his right, title and interest in and to the Marks and Assignee does hereby accept same and does hereby assume any and all obligations, duties, and liabilities with respect to same.
2. **Assignor’s Representations.** Assignor hereby represents and warrants to Assignee that he is the rightful and legal owner of the Marks and that he has the full legal right and authority to assign all right, title and interest in and to same to Assignee.
3. **Governing Law.** This Assignment shall be governed by Maryland law. Any disputes arising hereunder shall be heard in the courts of Frederick, Maryland unless the law requires otherwise.

The Parties do hereby evidence their respective agreement to the terms and conditions set forth, above, with their signatures, below, made as of the Effective Date.
