RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of October __, 2015 (this “Release”), is made by DOMINO’S IP HOLDER LLC, a Delaware limited liability company (“Secured Party”), in favor of DOMINO’S PIZZA PMC LLC, an Delaware limited liability company (“Grantor”).

WHEREAS, Grantor and Secured Party are parties to the Grant of Contingent Security Interest in Trademarks (the “Trademark Security Agreement”), dated as of April 16, 2007, pursuant to which Grantor assigned, granted and conveyed to Secured Party a contingent security interest in, and lien on, certain intellectual property defined in the Trademark Security Agreement as the Securitization IP, including the United States trademarks and service marks, including the associated registrations and applications for registration, set forth in Schedule 1 attached hereto and all goodwill of any business associated and connected therewith or symbolized thereby and all products and proceeds of the foregoing (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on April 18, 2007, at Reel 3524 / Frame 0456; and

WHEREAS, Secured Party has agreed to terminate the Trademark Security Agreement and release its security interest in all such Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Secured Party hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all liens and security interests that it has in, to and under the Trademark Collateral.
2. Authorization to Record. Secured Party authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.
3. Governing Law. THIS GRANT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES (OTHER THAN SECTION 5-1401 AND 5-1402 OF THE GENERAL OBLIGATIONS LAW OF THE STATE OF NEW YORK).
