TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (“*Termination and Release*”) is granted as of October 21, 2015 by **SILICON VALLEY BANK**, as Administrative Agent (the “*Assignee*”), in favor of **DIGICERT, INC.**, a Utah corporation, **UNICORN ACQUISITION SUB CORP.**, a Delaware corporation and **DIGICERT HOLDINGS, INC.**, a Delaware corporation (collectively, the “*Grantors*”);

WHEREAS, the Grantors executed and delivered a Trademark Security Agreement dated as of November 30, 2012 (the “*Trademark Security Agreement*”) granting the Assignee a security interest in and lien on all of Grantor’s right, title and interest in, to and under (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, Internet domain names and other source or business identifiers, (ii) all goodwill associated therewith, now existing or hereafter adopted or acquired, (iii) all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, (iv) all common-law rights related thereto, including, without limitation, any of the foregoing referred to on Schedule A hereto, and (v) the right to obtain all renewals thereof, to the extent included in the Collateral (the “*Original Marks*”) and other collateral (if any) as described therein;

WHEREAS, the Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on November 30, 2012, at Reel 4910, Frame 0706;

WHEREAS, the Grantors executed and delivered an Amended and Restated Trademark Security Agreement dated as of June 2, 2014 (the “*A&R Trademark Security Agreement*”) granting the Assignee a security interest in and lien on all of Grantor’s right, title and interest in, to and under (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, Internet domain names and other source or business identifiers, (ii) all goodwill associated therewith, now existing or hereafter adopted or acquired, (iii) all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, (iv) all common-law rights related thereto, including, without limitation, any of the foregoing referred to on Schedule A hereto, and (v) the right to obtain all renewals thereof, to the extent included in the Collateral (the “*A&R Marks*”); together with the Original Marks, the “*Marks*”) and other collateral (if any) as described therein;

WHEREAS, the A&R Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on June 2, 2014, at Reel 5293, Frame 0788;

WHEREAS, Assignee has agreed to release its security interest in all of the right, title, and interest of the Grantor in the Marks, and to reconvey any and all right, title, or interest it may have in the Marks to Grantor; and


WHEREAS, the Grantors have requested that the Assignee provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks, and the other collateral described in the Trademark Security Agreement and A&R Trademark Security Agreement, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby releases, relinquishes and discharges all of its liens and security interests in all of Assignee's right, title and interest in, to and under (a) the Marks, including without limitation the trademarks and trademark applications identified on Schedule I, and (b) the other collateral described in the Trademark Security Agreement and A&R Trademark Security Agreement, including without limitation the domain names identified on Schedule II, and re assigns to Grantor any and all right, title or interest it may have in the foregoing, all without warranty and representation of any kind.
