

("Jam"), the wholly-owning parent company of the Assignor, pursuant to which the Assignee has granted to Jam the exclusive right to distribute the Products throughout Canada and United States.

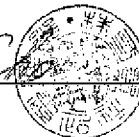
