

Assignor undertakes to duly execute, or have duly executed by its subsidiaries or relevant affiliates, those trademark assignment instruments or other documents necessary to record the transfer of title effected hereby.

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents and trademarks or other evidence or forms of industrial property protection on applications as aforesaid, to record all trademarks transferred hereunder and title thereto, as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this General Trademark Assignment, and to issue the same to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.


