**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of October 22, 2015 (this “Release”), is made by THE CIT GROUP/BUSINESS CREDIT, INC., in its capacity as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”), pursuant to the Pledge and Security Agreement, dated as of May 28, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Pledge and Security Agreement.

W I T N E S S E T H

WHEREAS, The Paradies Shops, LLC, a Georgia limited liability company (the “Company”), is party to the Pledge and Security Agreement;

WHEREAS, pursuant to the Pledge and Security Agreement, the Company executed (i) the Trademark Security Agreement dated as of May 28, 2010 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office (“USPTO”) on June 10, 2010 at Reel/Frame No. 4222/0583 and (ii) the After-Acquired Trademark Pledge and Security Agreement (First Supplemental Filing) dated as of May 10, 2013 (the “First Supplement”) and recorded with the USPTO on May 21, 2013 at Reel/Frame No. 5032/0065, in each case, pursuant to which the Company granted to the Collateral Agent a security interest in and continuing lien on all of the Company’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement and the First Supplement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:


The Collateral Agent hereby TERMINATES, without recourse, representation or warranty the Trademark Security Agreement and First Supplement, and RELEASES, without recourse, representation or warranty its security interest in and lien upon all of the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I, attached hereto and incorporated herein by reference.

The Collateral Agent agrees to provide the Company with any additional authorization reasonably necessary to effect the release of the Collateral Agent’s security interest in the Trademark Collateral.
