**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Release*") is made as of October 22, 2015 (the "*Effective Date*"), by Wilmington Trust, National Association, as second lien administrative agent and collateral agent on behalf of the Secured Parties (the "*Agent*"), in favor of Affordable Care, Inc., a North Carolina corporation with offices at 1400 Industrial Drive, Kinston, North Carolina, 28504 (the "*Grantor*").

**WHEREAS**, pursuant to the terms and conditions of that certain Second Lien Trademark Security Agreement between the Grantor and the Agent, dated as of December 26, 2012 (the "*Trademark Security Agreement*"), the Grantor pledged and granted to the Agent a lien on and security interest in all of its right, title and interest in and to certain collateral identified in such Second Lien Trademark Security Agreement, including, without limitation, the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the "*Released Trademarks*");

**WHEREAS**, the Second Lien Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on December 26, 2012, at Reel 4928 and Frame 0978;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Released Trademarks arising under the Second Lien Trademark Security Agreement, including all goodwill connected with the use of, and symbolized by, each such Trademark.

If and to the extent the Agent has acquired any right, title or interest in or to any of the Released Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Grantor.

The Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, and at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.


